TRUEPAD's main feature is that a user can post content anonymously through the user id number made by the user while signing in. The aim is to encourage conversations on real life issues without fear of identity revelation. TRUEPAD does not encourage illegal, harmful, coercive, threatening or demeaning behaviour.

TERMS OF USE

By accessing or using TRUEPAD, or any of TRUEPAD's products, software, data feeds, and services provided to you on, from, or through the TRUEPAD application, you agree to be bound by these terms of use as stated below.

All references to "you" or "your", as applicable, means the person that accesses, uses, and/or participates on TRUEPAD in any manner ("User").

If you use TRUEPAD on behalf of an entity, you represent and warrant that you have the authority to bind that entity. Your acceptance of the Terms of Use will be deemed an acceptance by the entity you represent and "you" and "your" herein shall refer to such entity.

TRUEPAD is an intermediary limited to providing access to a communication system over which information will be made available by third parties and transmitted by them or temporarily hosted or stored by them. TRUEPAD shall not be deemed to have conspired or abated or induced whether by threats or promise or otherwise or other the commission of an unlawful act by any of its Users.

These Terms of Use constitute a legally binding agreement between TRUEPAD and you. By installing, downloading or even merely using TRUEPAD, and by clicking on "I have read and agree to the terms of use" you shall be contracting with TRUEPAD and you signify your acceptance to the Terms of Use and other TRUEPAD policies as posted by TRUEPAD from time to time and create a legally binding arrangement to abide by the same, which take effect on the date on which you download, install or use the services. - 7. You hereby certify that all information you have provided or will provide to TRUEPAD upon registration and at all other times will be true, accurate, correct and complete and you agree to update your information as necessary to maintain its truth and accuracy;
- 8. You agree that you shall not solicit, collect or use the login credentials of other TRUEPAD Users for any reason whatsoever. You shall not try to gain unauthorized access or exceed the scope of authorized access to TRUEPAD or solicits passwords or personal identifying information for commercial or unlawful purposes from other Users;

- 19. - 22. You shall not promote any illegal or unauthorized copy of another person's copyrighted work (see "copyright complaint" below for instructions on how to lodge a complaint about uploaded copyrighted material), such as providing pirated computer programs or links to them, providing information to circumvent manufacture-installed copy-protect devices, or providing pirated music or links to pirated music files;
- 23. TRUEPAD does not claim any ownership over the Content posted by you. The Content shall be owned by you and any liability whatsoever as a consequence shall be yours;
- 24. You shall not post information that contains restricted or password-only access pages, or hidden pages or images (those not linked to or from another accessible page);
- 25. You shall not provide material that exploits people in a sexual, violent or otherwise inappropriate manner or solicits personal information from anyone;
- 26. You shall not provide instructional information about illegal activities such as making or buying illegal weapons, violating someone's privacy, or providing or creating computer viruses;
- 27. You shall not solicit gambling or engage in any gambling activity which is or could be construed as being illegal;

- 39. TRUEPAD reserves the right, but has no obligation, to monitor the materials posted on TRUEPAD;
- 40. You shall not create accounts with TRUEPAD through unauthorized means, including but not limited to, by using an automated device, script, bot, spider, crawler or scraper;
- 41. You understand that when using TRUEPAD, you may be exposed to Content from a variety of sources, and that TRUEPAD shall not be responsible for the accuracy, usefulness, safety, or intellectual property rights of or relating to such Content;
- 42. When you use TRUEPAD, some personal information is collected from and about you. We are committed to protecting the security of this information and safeguarding your privacy. This privacy policy sets out the details of the personal information collected, the manner in which it collected, by whom as well as the purposes for which it is used. ("**Privacy Policy**") At registration you accept the terms of this Privacy Policy and your use of the App signifies your continued acceptance thereof. This Privacy Policy may be revised from time to time and you will be notified of all such changes.

1. When you register on the App, the following information is collected from you and stored securely on a server managed by TRUEPAD – (i) name; (ii) phone number; (iii) email id (iv) IMEI (International Mobile Equipment Identity) number. This information will be stored on a leased Server, managed by the administration of TRUEPAD. This information does not qualify to be sensitive personal information as per the laws, rules and regulations in India. This information will thereafter be used to identify you in all subsequent App related transactions and will be associated with any data or information uploaded from the App to the Server. You give us permission to show your username, profile picture and information about your action (such as likes) or relationships (such as follows) in connection with your account;

- 2. The personal information collected from you at the time of registration under Clause 1 above, will be stored on the server and only be used for no other purpose apart from security purposes;
- 3. The App is equipped with standard security features to protect the confidentiality and security of your information. Data is encrypted in transit as well as at rest. Personal information provided at the time of registration is encrypted before being uploaded to the cloud where it is stored in a secure encrypted server. Personal information that is stored in the Apps of other registered Users that you come in contact with is securely encrypted and are incapable of being accessed by such user;
- 4. TRUEPAD shall not share details provided by the you while signing in with any other User, third party or authority unless legally bound to do so;
- 5. Upon inactivity of account as per clause 10 of Basic Terms all information collected from you under Clause 1 at the time of registration will be retained on the leased server of TRUEPAD for 180 days;
- 6. We may share your information with a parent company, any subsidiaries, joint ventures, or other companies under a common control (collectively, "Affiliates"), provided that we require our Affiliates to honour this Privacy Policy. As we develop our business, we might sell or buy businesses or assets. In the event of a corporate sale, merger, reorganization, dissolution or similar event, personal data collected may be part of the transferred assets.
- 7. Upon your request, we will take reasonable steps to correct, amend, or delete your personal data that is found to be inaccurate, incomplete or processed in a manner non-compliant with this Privacy Policy or applicable law, except where the burden or expense of providing access would be disproportionate to the risks to your privacy, where the rights of persons other than you would be violated or where doing so is otherwise consistent with applicable law. Please note that while any amendments, corrections or deletions will be reflected in active User databases (as updated with a reasonable period of time), we may retain all personal data for backups, archiving, prevention of fraud and abuse, analytics, and satisfaction of other legal obligations we reasonably believe applicable as mentioned in clause 5 of this Privacy Policy;
- 8. As a TRUEPAD account holder you submit all Content to TRUEPAD, including videos, photos, text, audio and User comments. TRUEPAD does not guarantee any confidentiality and privacy with respect to any Content you submit;
- 9. TRUEPAD may also disclose that Content and metadata if required to do so by law or in the good faith belief that such preservation or disclosure is reasonably necessary to: (i) comply with legal process; (ii) enforce these Terms of Use; (iii) respond to claims that any Content or metadata violates the rights of third-parties; or (iv) protect the rights, property, or personal safety of TRUEPAD, the services, its Users and the public;
- 10. Upon receiving actual knowledge or being notified by the government or its agency that any information, data or communication link residing in or connected to the resource

controlled by TRUEPAD is being used to commit an unlawful act TRUEPAD shall expeditiously remove or disable access to that material on that resource, though shall preserve such records for a period of 180 days or for such time the government or its agency may require. COMMUNITY GUIDELINES

When you use TRUEPAD, you join a community of people from all over the world. The guidelines below help keep TRUEPAD fun and enjoyable for everyone. If you see content that you think violates these guidelines, use the flagging feature to submit it for review by TRUEPAD.

Please take these rules seriously. If TRUEPAD's creator's on- and/or off-platform behaviour harms our Users, community, employees or ecosystem, we may respond based on a number of factors including, but not limited to, the egregiousness of their actions and whether a pattern of harmful behaviour exists. Our response will range from suspending a creator's privileges to account termination.

Best practices for creators

Here are some rules that will help you understand our policies and steer clear of trouble.

TRUEPAD is not a home for glorifying violence or promoting hate. Graphic or controversial footage may be allowed if it's educational but it must be preceded by age-restrictions or a warning screen.

Context is very important for all videos, but it's particularly important when posting graphic content. Content that is educational, scientific, newsworthy, or a documentary may often contain graphic content. This type of content is allowed on TRUEPAD only if it includes context. Adding details and trigger warnings explaining your video or photo helps Users find and understand your content while making an informed personal choice to not watch them. It also helps the TRUEPAD team review your post if it gets flagged.

For example, a video posted by a citizen journalist capturing footage of protesters being beaten would likely be allowed if it includes relevant context. In this example, relevant information could be a list of tips at the beginning of the video on how to stay safe when at a protest. Or, a voice-over narration about the protest's history. The video should also have a clear title or description indicating what it is reporting on or documenting the content.

Appropriate Content

The TRUEPAD Community is built on trust. Content that intends to scam, mislead, spam, or defraud other users isn't allowed on TRUEPAD. These may be through spams, impersonation, links within your content or fake engagement.

We hope to protect viewers, creators, and especially minors and victims. Content showing nudity, sexual episodes, suicide, self-harm, hate speech, predatory behaviour, graphic violence, malicious attacks, harassment and cyber bullying, and content that promotes harmful or dangerous behaviour do not find any place on TRUEPAD.

Regulated goods

No Content selling firearms, explosives, ammunitions or instruments of such mass destruction shall be sold, advertised or promoted on TREUPAD.

Creator influence on and off Truepad

As TRUEPAD creators, you remain responsible both on and off the platform. If we see that a creator's on- and/or off-platform behaviour harms our Users, community, employees or ecosystem, we may take action to protect the community.

Beyond the content you upload on TRUEPAD, here are some examples of on- and/or offplatform behaviour that we may consider to be inappropriate and force TRUEPAD to levy restrictions in addition to standard enforcement action:

- 1. Intending to cause malicious harm to others.
- 2. Participating in abuse or violence, demonstrating cruelty, or participating in fraudulent/deceptive behaviour leading to real world harm.

These restrictions include:

- 1. Termination of TRUEPAD account
- 2. Your videos, photos, posts may no longer be eligible to be recommended on TRUEPAD, and could lose benefits such as appearing on our home page, trending tab, or in watch next recommendations.

CONTENT AND CONDUCT

- 1. You affirm, represent, and warrant that you own or have the necessary licenses, rights, consents, and permissions to publish Content you submit on TRUEPAD;

- 2. You may print off a copy, and may download extracts, of any page(s), files or other content from TRUEPAD for your personal reference and you may draw the attention of others within your organisation to material available on TRUEPAD;

- 3. You acknowledge and agree that content contained in the services or information presented to you through the services on TRUEPAD may be protected by copyright, trademark, or patent law, or other proprietary rights and laws. Except as expressly authorized by TRUEPAD or its affiliates, you agree not to modify, distribute, copy, reproduce or create derivative works based on the proprietary portions of the services, in whole or in part;
- 4. You shall not reverse engineer, decompile, or disassemble the services of TRUEPAD or its underlying technologies, except to the extent the foregoing restriction is expressly prohibited by applicable law. Those portions of the services owned by TRUEPAD are the copyright of TRUEPAD. All rights reserved. You agree that all of TRUEPAD's trademarks, trade names, service marks, logos and service names are trademarks and are a property of TRUEPAD.

GENERAL CONDITIONS

- 1. TRUEPAD reserves the right to modify or terminate the service or access to service for any reason, without notice, at any time:
 - i. if any User Content provided during the registration process or thereafter proves to be inaccurate, not current or incomplete;
 - ii. if it is believed that your actions may cause legal liability for you, other Users or TRUEPAD:
 - iii. if you are found to be non- compliant with these Terms of Use.
 - iv. For any other reason that TRUEPAD deems reasonable.
- 2. You can deactivate (and not terminate/delete) your TRUEPAD account by logging in and filling the delete account form in the settings.
- 3. Upon termination as per clause 1 and deactivation as per clause 2 mentioned above, your photos, comments, likes, friendships, and all other data will no longer be accessible through your account (e.g., Users will not be able to navigate to your username and view your photos), but those may persist and appear within the service (e.g., if your Content has been reshared by others).
